**Registration and Payment Policy:** There is a **once yearly non-refundable registration fee of \$25** per student (maximum \$40 per family). If registration was paid for Session I in September, it is not necessary to pay again in January for Session II. Classes may be cancelled by administration due to insufficient registration within the first 2 weeks of a session. 3 year olds must be 3 by Jan 1st. **Payment:** Payment in the form of check or credit card is required at the time of registration in order to secure placement in class. **Recital:** A recital is planned for May 2018. There will be additional recital, costume and ticket fees. **Siblings are not guaranteed placement in same show.** **Refund Policy: There are NO refunds.** There are **no refunds for weather related cancellations.** If notification of withdrawal from a class is received by January 1, 2018, all program fees will be refunded with the exception of a 10% handling fee and \$25 registration fee. Refunds for cancellations received after January 1, 2018 will be granted under the following circumstances: The family is moving to another community; the child has a medical problem; a 2 or 3 year old is unable to adjust after a 3 class transition period. Refunds issued under these circumstances will be prorated for classes attended and will be subject to a 10% handling fee. There will be no credits or refunds given to classes missed in this 3 class trial period.
